Vertu Motors plc (AIM: VTU) announces that on 29 May 2019, it purchased 19,512 ordinary shares of 10p each in the Company on the London Stock Exchange (the "Repurchased Shares"), pursuant to the share buyback programme (the "Buyback Programme") that was announced on 10 October 2018 as follows:

The Company holds no shares in treasury.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.

The Group currently operates 120 franchised sales outlets and 3 non-franchised sales operations from 104 locations across the UK.
